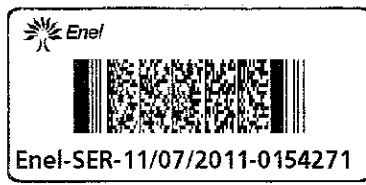

Further to your application for qualification, we would advise you, in name and on behalf of Enel S.p.A., that the consequent qualification procedures carried out in respect of your company have proved successful.

Your Company has been recognised as being "suitable" for the performance of contracts relating to:

- **FEQE27 - POWER SUPPLY SYSTEMS FOR AUXILIARY SERVICES**
which may be involved for annual orders to a value of euro up to 6.000.000 Euros.

So that this business can be carried on, your company is, therefore, being entered in the appropriate Register of ENEL approved Companies.

We would also advise you that within the meaning of ENEL's current Regulations on the qualification procedures for Companies, this suitability is valid for a three-year period effective from 05/07/2011 and that the entering of your company in the Register of ENEL approved Companies does not commit ENEL in respect of any orders.

On the expiry of the intended validity period, qualification can be renewed, for a further three years by means of the appropriate renewal procedures.

We would, moreover, point out that suitability and, therefore, the entering of your company in the Register of approved Companies as specified above may be suspended or revoked should (by way of example and not limited to these) there be any of the following:

- substantial changes in the types and/or technologies of the productions, work and/or services;
- serious non-fulfilment at the pre-contract phase and/or termination of contracts for misconduct;
- bankruptcy proceedings;
- circumstances covered by the current "Anti-Mafia Regulations";
- serious or fatal accidents suffered by the workers employed to carry out any contract possibly awarded;
- etc.

In particular, the occurrence of serious or fatal accidents may entail the immediate suspension of the qualified company directly involved and in cases where the accident had occurred to the personnel of a contractor belong to a Consortium or 'Raggruppamento Temporaneo di Imprese' (*Temporary Group of Companies*) (the so-called RTI) qualified for the abovementioned merchandise groups, taking account of the safety coordinating role entrusted to the unit head/representative, Enel may suspend the abovementioned persons too.

Qualification will also be subject to review for the purposes of reconfirmation in the event of changes in your shareholding structure and/or ownership, changes in the corporate name or registered office, restructuring, incorporation, demerging, assignment, mergers, changes, etc.

For the purpose of monitoring corporate progress, your Company is bound every year to submit the Annual Accounts (with any official Annexes) as well as notifying ENEL without delay of the aforementioned events and conditions, subject to the penalty of possibly being removed from the Register.

Moreover, we hereby advise you that Enel has put in place a Vendor Rating system aimed at monitoring and evaluating performance levels on the services provided by their own suppliers and contractors as well as on the products purchased.

Therefore, Enel will, in respect of qualified companies, collate objectively and systematically information on the conduct of companies during the carrying out of the provision procedures as well as during the execution of contracted services and, in particular, in connection with the:

- quality of the goods supplied (the so-called "IQ");
- proper timing of services provided (the so-called "IP");

- accuracy at the pre-contractual phase and the executing phase (the so-called "IC").

The Vendor Rating Index (the so-called IVR), obtained from the above results, is used by Enel to draw up an overall evaluation of each supplier in relation to the various types of services provided and/or goods supplied. The aforementioned evaluation may result in, for instance, the suspension of the qualification already obtained or conversely the simplification of the renewal procedures for the qualification itself.
